Under the Authority contained in Cir No 3, Hq ETOUSA, June 13, 1942, Subject: "Allowances" the above named officers will be allowed, in lieu of Subs a flat per diem of six (\$6.00) dollars while on travel status and in the event rations and qrs are not furnished at TD sta, a flat per diem of five (\$5.00) dollars while on such TD.

It being impracticable for the Govt to furnish cooking facilities for rations the FD will pay the above named EM the monetary Travel Alws prescribed in Table II, Par 2a, Ar 3504520, as changed by WD Cir 50, 1941, at the rate of \$2.50 per day for the above named EM, while on a travel status and in the event qrs and rations are not furnished at TD Sta, at the rate of \$2.50 per day for rations and at the rate of \$4.00 per day for qrs for the above named EM while on TD.
